WELCOME TO THE MARCH EDITION OF FECCA'S e-NEWS

Welcome to the third edition of the FECCA e-newsletter for 2017. This month a major focus of FECCA's work has been the 18C debate where FECCA and its partner organisations have been at the forefront of the fight to maintain 18C and the protections from racial vilification and discrimination it provides to Australia's diverse community.

FECCA's major campaign on 18C allowed FECCA to lead the debate and attract broad coverage of our position across the media including in the Guardian, Australian, Australian Financial Review, ABC and SBS. FECCA also appeared in front of the Senate Inquiry into the *Human Rights Legislation Amendment Bill 2017* that attempted to introduce changes that would weaken 18C and the *Racial Discrimination Act*. FECCA was delighted when the Senate backed FECCA and other organisations including Indigenous bodies campaigning against changes to 18C by rejecting attempts to water down Australia's hate speech laws. I am saddened by the way that the Government

decided to revive this issues when the majority of multicultural Australia made its feelings very clear when it was first raised by the Abbott administration.

Alongside the work on 18C, FECCA has also kept up its advocacy in other areas. We have made submissions to inquiries on issues including the Omnibus Bill, Gender Segregation in the Workplace, the Strong and Resilient Communities Grants program, the Foreign Policy White Paper, the Administrative Appeals Tribunal Harmonisation Project, Elder Abuse and the Government's proposed changes to the Pension Portability Scheme.

This month the Government launched their Multicultural Policy Statement, "Multicultural Australia - united, strong, successful". FECCA gave a cautious welcome to the statement and looks forward to concrete

policy proposals and resources to follow on from the statement that will support and strengthen Australia's multicultural society.

Harmony Day was celebrated in Australia on the 21 March and communities across the country celebrated Australia's fantastic diversity. We celebrated our own diversity right here at FECCA holding Harmony Day celebrations in the office, with guests from the Settlement Council of Australia, the National Ethnic Disability Alliance and colleagues from local companies who share our building who brought along delicacies representing their cultural heritage.

We continue to plan for our conference in Darwin later in the year and our conference website will be launched later this month. It is shaping up to be an exciting event and we hope to see you all there.

FECCA NEWS

Submission to the Administration Appeals Tribunal Harmonisation Project

The AAT Harmonisation Project seeks to provide a new set of principles which apply across the Tribunal's jurisdictions to improve, simplify and make more efficient its processes. The AAT hears appeals on a number of federal issues including immigration decisions. FECCA made a submission that focused on ensuring that the rights of individuals from CALD communities appearing

at the AAT are protected throughout the process. The submission noted, for example, the importance of applicants having access to all of the information provided to the Tribunal by both sides; the availability of language services; the importance of procedural fairness; and flexibility in lodging an appeal.

Submission on the Redesign of the Strengthening Communities Grants Program

The Strong and Resilient Communities Grants Program, formerly the Strengthening Communities Program, provides funding for organisations which seek to create social cohesion and address emerging community need. The program recently went through a redesign process, to which FECCA made a submission. FECCA emphasised, for example, that priority should be given to proposals that make cultural expression a key element of their program and which specifically address cross-cultural

misunderstandings and misconceptions in innovative ways. We also highlighted that smaller organisations often lack capacity for sophisticated data management and that evidence provided anecdotally – the articulation of a communities' shared experience – should be given appropriate consideration.

Foreign Affairs White Paper

The Department of Foreign Affairs and Trade called for submissions to the Foreign Policy White Paper, the first since 2003. FECCA submitted that Australia's Foreign Policy should be underpinned by conscious reference to, and understanding of, the multicultural nature of its population. FECCA highlighted that it is important that the Government engage and consult with communities regarding policies that affect their regions of origin and they must also be cognisant of the likely impact of any decision on cohesion between communities. Further, Australia is home to communities of people from every nation on Earth. Many of these people are highly skilled in a broad spectrum of industries and are from places

with whom Australia intends to maintain, or in some cases increase, its cultural and economic connections. Policy makers should search for innovative ways to harness the resource represented by these persons and their communities.

FECCA also highlighted that Australia should give close consideration to its obligations to the global community as expressed in the international instruments to which it is a signatory.

Social Services Legislation Amendment (Omnibus Savings and Child Care Reform) Bill 2017

The Social Services Legislation Amendment better known as the 'Omnibus Bill' includes a number of reforms and cost savings measures which will impact many of the communities that FECCA represents. FECCA made a submission highlighting our concerns with a number of proposals contained in the bill including changes to the portability of benefits in relation to the Age Pension. FECCA argued that there is a substantial equity issue with a measure, such as pension portability, that will disproportionately impact Australia's migrants.

FECCA also highlighted our concerns regarding the proposal to impose a four week waiting period for a person under 25 assessed as job ready to be able to access income support. In many cases younger members of CALD communities are important providers to family units and the gap created by the waiting period will cause significant hardship.

A version of the Bill was passed a short time later but the provisions we opposed were separated from that piece of legislation. A copy of the submission is available at FECCA's website [here](#).

Elder Abuse Inquiry

The Australian Law Reform Commission held an inquiry into existing Commonwealth laws and frameworks which seek to safeguard and protect older persons from misuse or abuse by formal and informal carers, supporters, representatives and others.

FECCA made the following contribution to that inquiry supporting the proposal to develop a National Plan to address elder abuse. We encouraged the adoption of specific measures to address challenges faced by people from CALD backgrounds and the development of culturally appropriate responses.

For example, FECCA recommended that older people are educated about their rights, provided with access to culturally appropriate advocacy services and with opportunities to confidentially discuss their concerns with legal professionals. FECCA emphasised the importance of adopting measures to ensure professionals working with older people from CALD backgrounds are culturally competent.

FECCA continues to work on this important area. The report from that inquiry is yet to be released but the full terms of FECCA's submission is available on FECCA's website [here](#).

Better Management of the Social Welfare System Initiative

The Better Management of the Social Welfare System Initiative is an initiative of the Department of Human Services aimed at collecting overpayments of benefits made to individuals by way of automated data matching that has resulted in the sending of letters of demand.

FECCA made a submission to the inquiry regarding this system of debt-collection.

Homelessness and Domestic Violence

The Public Interest Advocacy Centre has released a report, based upon two years' worth of consultations with women at risk of homelessness, which argues that more resources are needed to address the complex legal needs of women escaping domestic violence. According to the Report's author, Louis Schetzer, participants' stories illustrated the difficulties faced by women in finding safe, stable accommodation following the physical and emotional trauma of domestic violence. They also highlighted the importance of specialist legal services to address complex and interrelated legal needs. In a related context when community

legal centres, which are at the front line of providing legal assistance to the most at-risk members of the community, are facing a Federal funding cut of almost 30% from 1 July.

FECCA opposes the cuts and reminds our members that Community Legal Centres do so much for ethnic communities around the country. The legal centres need our support now more than ever. FECCA also highlights that women from CALD communities can be at an increased risk of the issues raised by the report. Find a copy if it [here](#).
